To achieve a full 4K60Hz image, it is recommended that **Premium HDMI Cables** no longer than 7m on the **HDMI Input** and 7m on the **HDMI Output** ends are used.

Installation and Operation

- 1. Ensure all of the **Devices** are powered **Off**.
- 2. Connect an HDMI Cable to the HDMI Output Port on the HDMI Source Device and to the HDMI Input Port on the HDMI Signal Booster and Extender.
- 3. Connect an HDMI Cable to the HDMI Output Port on the HDMI Signal Booster and Extender and to the HDMI Input Port on the HDMI Display Device.
- 4. Power **On** all of the **Devices**.
